- 7. **Program Highlight** Presented Scott Gunderson, Ag Agent. Scott reported on recent programming including the Custom Manure Hauler and Agronomist workshop on March 7. Thirty-eight haulers and agronomists participated in the workshop. A post-meeting evaluation of the workshop indicated over 340 farms were represented by the 25 people who completed the evaluation. They worked with farmers working 140,000 acres of cropland and nearly 62,000 cows. All participants completing the evaluation said the meeting was worth their while and they would recommend it to co-workiers.

Scott also reviewed the worsening financial crisis in the dairy industry in Wisconsin. Low milk prices and other factors are threatening the loss of many dairy farms in the state. The amount of stress this is bringing to farm families and rural communities is alarming and many organizations across the state are intensifying their programming to assist. Manitowoc County leads the state in milk pounds produced per cow. Milk prices were at \$24/100 lbs in 2014, and today they are \$15/100.

Scott also referred to a letter from Revolution Plastics that requests counties to financially support their agricultural plastics recycling business. Despite the letter making mention of UW-Extension as supporting this request, Scott emphasized that this is NOT the case. Extension does NOT endorse the request or the letter sent to some counties by Revolution Plastics.

8. **Dept. Director Report:** Burke reported that Ashley in the IT department has been very helpful to the Extension Office in navigating the changes caused by the Madison-Extension merger and the issue of licensing of county support staff for Office 365 and other programs.

Burke circulated the draft position description for the .5 FTE Health and Well-being Educator for Manitowoc County. The position description is in the Health and Well-Being Institute at this time and we are awaiting their approval and will continue the process as fast as possible.

No new developments or complications to report on the pending change of this committees name to the Extension Education and Agriculture Committee.

Burke reviewed the latest office newsletter with articles from the youth/4-H program, Agriculture, and FoodWise.

Budget execution is on track, and Burke referred to and summarized the standard annual County-FoodWise agreement letter that will go to the County Executive for endorsement.

- 7. **Program Highlight** Youth 4-H Educator Kevin Palmer reported on new developments with. the 4-H Shooting Sports program. Shooting Sports is a project within the 4-H program with six different disciplines offered in Wisconsin archery, county coordinator, muzzleloader, pistol, rifle, and shotgun. The most recent development addresses the fact that adult volunteers must become certified in a discipline before they can work with youth. Currently, volunteers must attend a Friday night session on youth development, program implementation, risk management, and roles and responsibilities, followed by a Saturday discipline-specific training. Overall a major time commitment for a volunteer to undertake. Kevin recently represented Wisconsin at the National 4-H Shooting Sports Conference/Workshop, which was held at West Virginia University's Jackon's Mill State 4-H Camp. A highlight of the conference/workshop was the debut of four new online training modules that were developed at the national level to replace the Friday night session. The modules will be available for use by States on November 1. One of the obstacles to recruiting volunteer shooting sports leaders is that they often have to pay for overnight lodging and meals.

Is to attend the Friday/Saturday trainings. With the new online modules available, volunteers will be able to complete them at home. They can then attend only the discipline-specific training on Saturday and eliminate the need and expense for overnight lodging.

Kevin also reviewed an upcoming course he will be providing on Chainsaw Safety at Camp Tapawingo on Saturday, November 9.
