LAND INFORMATION COUNCIL MEETING MINUTES OF DECEMBER 17, 2020

The meeting was called to order by Chair Tim Ryan at 10:03 a.m. in the Manitowoc County Communication and Technology Building, 1024 South 9th Street, Manitowoc.

Members present: Jason Bolz, Supervisor James Falkowski, Amy Kocian, Matt Randerson, Tim Ryan, Travis Waack, and Supervisor Catherine Wagner. Aprille Calewarts and Jill Pope attended via Zoom. Krisi Tuesburg was absent.

Travis Waack made a motion to approve the agenda; it was seconded by Amy Kocian and passed.

Amy Kocian made a motion to approve the minutes; it was seconded by Jason Bolz and passed.

No correspondence was received.

No members of the public wished to speak.

The removal of the public representative position from County Code 2.04(7m)(b) was discussed. The position had been vacant for years until it was recently filled by Supervisor James Falkowski. Travis Waack made a motion to move this item to unfinished business and reevaluate before Supervisor James Falkowski's term ends in 2022; it was seconded by Amy Kocian and passed.

The county's 2021 Wisconsin Land Information Program grant application was discussed. The first project listed in the grant application is a large format printer for the Planning and Zoning Department for \$5,195.00. This is listed in the Manitowoc County 2019-2121 Land Information Plan as "other costs not associated with a specific project". The second project listed in the grant application is new land records software from Transcendent which would use the remaining \$44,805.00 of the \$50,000.00 grant. Amy Kocian discussed how this new software would benefit the Treasurer's Department. Matt Randerson discussed how this would benefit the Planning and Zoning Department. Tim Ryan mentioned that the services estimate section of the contract provided by Transcendent should not be open-ended as that leaves the county exposed to increased costs. Alternative projects were discussed, including oblique imagery, Project #4: Road Right-of-Way Improvements, Project #7: Data Download Site, and Project #9: GIS Health Check. Jason Bolz made a motion to approve the grant application with the large format printer and Transcendent software; it was seconded by Supervisor James Falkowski and passed.

The next Land Information Council meeting will be held in June, 2021.

A motion to adjourn was made by Amy Kocian at 10:49 a.m.; it was seconded by Jason Bolz and passed.
