

# DRIVEWAY TERMS/CONDITIONS

## General

You are responsible for complying with State & Federal Laws concerning construction near or on wetlands, lakes & streams.

Wetlands that are not associated with open water can be difficult to identify. Failure to comply may result in removal or modification of construction that violates the law or other penalties or costs. For more information, visit the Department of Natural Resources Wetlands identification web page or contact a Department of Natural Resources Service Center. (2009 Wisconsin Act 373, 2009 Senate Bill 557).

## Driveway Conditions

Driveway side slopes shall be of earth material, covered with black ground and seeded.

No concrete or bituminous side slope will be allowed.

Side slope grade shall be no less than 3 to 1.

Pipe, diameter and length will be determined by a Manitowoc County Highway Department representative.

No concrete on right-of-way.

The driveway surface must be a flexible material on County Right-of-Way (asphalt or gravel) with a maximum driveway surface top for agriculture entrance not to exceed 45 feet.

The culvert must be a minimum of 5 feet from property line and at right angles to the roadway.

If a driveway is removed, area needs to be restored to match existing ditch, with black ground and seeded with erosion matting.

Apron end walls are required.

Once project is started, all work must be completed within 60 days and all conditions must be met.

A stake, flag or some other identifying marker must be placed on each end of proposed installation. A diagram may be attached to this application.

Please notify Manitowoc County Highway Department (MCHD) when project is complete.

Width of drive. No Residential driveways shall have a width less than 16 feet nor greater than 24 feet measured at the property line.

## Blacktopping Driveways

Driveways must be graded so that the water is diverted to the sides and not drained onto the highway and low enough to avoid snow removal problems.

## Conditions Agreement

In the performance of this work, I will comply with all terms and conditions of any permit that may be issued by the State or Manitowoc County Highway Department. This permit will expire Sixty (60) days from the date of approval. Manitowoc County reserves the right to correct any deficiencies that have not been addresses after the 60-day inspection and the applicant will be responsible for all costs involved.

The Owner and his contractor shall conduct operations in the Manitowoc County highway right of way in a manner consistent with Work Zone requirements proscribed in the current edition of the Manual of Uniform Traffic Control Devices. Appropriate signing and traffic control shall be the responsibility of the Owner. The Owner and his contractor shall restore all right-of-way topsoil and vegetation removed as part of the installation project and provide appropriate erosion control. The Owner shall protect the highway shoulder and pavement structure from damage. Failure to work safely in the highway right-of-way; failure to properly restore the highway right-of-way; or failure to protect the highway shoulders and pavement can result in the immediate revocation of this permit without recourse.
