Municipal candidates file with their respective municipal clerk. School Board candidates file with their respective school district clerk.

If a primary is necessary, the primary will be held on Tuesday, February 15, 2022.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID you may obtain a free ID for voting from the Division of Motor Vehicles.
