### COMPOST CLEANLINESS

Our community compost site needs your help to keep compost clean. While many people are mindful of what they drop off at our site, and observe our guidelines, there are people who choose to ignore them. The complete guidelines are listed on our website, on our main flyer, and on signs at the entrance to both the Basswood and Woodland Compost Sites.

After randomly inspecting many loads, we have identified ways you can improve compost cleanliness:

- ◆ Follow our posted guidelines. If you have a questionable material that is not mentioned in our guidelines, then contact our main office for guidance. Some common violations include: ashes, logs, topsoil, sod, rocks, and concrete.
- ◆ Inspect your loads for non-acceptable materials. Often times these items are off loaded with brush, leaves, or grass clippings. Remove any plastic bottles, bags, pots, tags, trays, landscape fabric, gloves, chainsaws.
- ◆ Take your trash home with you. We do not accept any garbage at our sites. Even if it is just one bag.
- ◆ When the curbside leaf/brush collection starts, make sure materials you put out are free of trash, because it ends up at our compost site. Make sure your truck or trailer bed is clean before loading yard materials in it.
- ◆ Hone in on the small stuff. All those snivels of plastic add up.
- ◆ Do not create piles of stuff you think others will scavenge. This is not an exchange site, we do not want potted plants lined up along our fence, or large firewood piles in the middle of the site.
- ◆ DO not mix brush in with the leaves, grass and garden debris. It should go in the BRUSH pile. Branches clog the screener when we sift finished compost.
- ◆ DO not mix leaves, grass and garden debris in with the brush pile. Yes, we realize there are leaves on the branches, the point is to minimize the material that gets chipped since it is a large expense.

Your efforts help us run more efficiently. Keeping compost clean saves staff time, disposal fees, hauling expenses, screening and grinding costs, and helps create better end products for your gardens and landscape projects.

LAMP RECYCLING is one of the services provided by the Manitowoc County Recycling Center's ongoing electronics collection program. Some lamps, including fluorescent tubes, compact fluorescent bulbs and high intensity discharge bulbs, contain small amounts of mercury that can be harmful to human health and the environment when they are disposed of in the trash. Even incandescent bulbs contain lead, which is also a toxic metal. All the materials in these bulbs can be recycled. During 2021 the Recycling Center collected approximately 13,146 bulbs from residents and businesses. Once received, the bulbs are carefully packaged for shipping to a specialized recycling facility where hazardous materials are safely removed. All the materials in these bulbs can be recycled without generating any waste. Even the hazardous materials, like mercury, can be recovered.

Bring your burnt out lamps and ballasts to main office at the Manitowoc County Recycling Center. When transporting large amounts of fluorescent tubes secure them in boxes or by taping them together in manageable bundles using an easy release masking or painter's tape (no duct tape).

\*There will be an additional charge for any broken lamps.

\*\*Do not use duct tape to bundle fluorescent lamps together, use an easy-release tape like painter's tape or masking tape.

**SMOKE DETECTOR DISPOSAL**

Neither the Recycling Center or Clean Sweep Program accepts unwanted smoke detectors. Certain types of smoke alarms contain trace amounts of radiation. The Environmental Protection Agency recommends that households return them to the manufacturer for proper disposal. Please contact the smoke detector manufacturer for instructions on proper disposal. Contact information should be available in the instruction manual, on their website, or on the back of the unit. Owners of unwanted Kidde smoke detectors can call 800-880-6788. Owners of First Alert and BRK smoke detectors should call 800-323-9005.

Residents who do not want to ship smoke detectors to manufacturers may dispose of them in the regular trash as they are not covered under current landfill bans.



**ELECTRONICS RECYCLING.** The Manitowoc County Recycling Center has an ongoing electronics collection program. A variety of electronics are accepted including televisions, computer equipment, kitchen gadgets, and electric tools. Items that cannot be accepted include Freon containing appliances like air conditioners, dehumidifiers, or refrigerators as well as bulky appliances like stoves, washers, or dryers.

It is important to recycle electronics for a number of reasons. They can contain hazardous materials that can enter the environment if disposed of improperly. Dumping or burning them can allow heavy metals and toxic compounds to infiltrate into the soil, air, and water. Heavy metals such as lead and mercury have the ability to leach out of electronic devices under certain conditions. These materials can cause a number of health problems in humans and wildlife. Electronics recycling helps recover reusable raw materials, conserves landfill space, and creates jobs.

Since 2010, Wisconsin's Electronic Recycling Law banned certain consumer electronic devices from landfills and incinerators and established a collection and recycling system in Wisconsin for households and K-12 public schools. Since then, the Recycling Center has recycled approximately 2.29 million pounds of unwanted electronics.

The Manitowoc County Recycling Center is registered with the Wisconsin Department of Natural Resources as a certified electronics collector. This means that ALL the electronics recycled through our program are sent to reputable recycling companies who guarantee the confidential destruction of any personal data remaining on your electronics, recycle or reuse all of the materials they receive, and are registered with the Environmental Protection Association and Wisconsin Department of Natural Resources.

All televisions and monitors are measured diagonally across the glass portion of the screen. Televisions and monitors must not be broken or stripped. Due to the increased health and safety issues associated with handling, storing, and transporting stripped electronics or broken televisions, these items may be refused or assessed an extra fee depending on the situation.

**FREON CONTAINING APPLIANCES**

Many customers stop in asking what do do with their air conditioners, dehumidifiers or refrigerators. We do not accept these items because we are not licensed to handle or remove Freon. There are other places in the area that do though. Be sure to call ahead for guidelines and pricing. If you have unwanted Freon containing items consider taking them to one of the following places:

**CLEAN SWEEP RESULTS**

The Manitowoc County Department of Public Works and Manitowoc County Recycling Center would like to thank all the participants and volunteers of the Hazardous Waste Clean Sweep program.

Clean Sweep is an annual collection event for hazardous waste items commonly found in households and farms, such as pesticides, solvents, cleaners, and oil based paints. Since it started in 1985, households and farms have turned in 1,158,180 pounds of unwanted chemicals.

This year the collection had 384 households, 12 farms, and 14 businesses participate and collected a total of 57,489 pounds of hazardous waste. Households turned in 28,622 pounds of hazardous chemicals. Farms turned in 15,212 pounds. Most of the items turned in were old oil based paints, though a significant amount of pesticides were also dropped off. The business portion of Clean Sweep served 14 local businesses who qualified as "Very Small Quantity Generators" under the program. These businesses brought in 13,655 pounds of hazardous waste. Businesses are offered a substantial discount when they bring their materials to the Clean Sweep event.

All of the collected items are properly recycled, neutralized or disposed of at special disposal sites or hazardous waste incinerators that render the materials harmless.

Clean Sweep is made possible partly through grant funding from the Wisconsin Department of Agriculture, Trade and Consumer Protection, a donation from the Ridgeview Landfill and volunteer labor. The Manitowoc County Recycling Center has a number of programs throughout the year that you can use to help our environment and clean up at home including Composting and Drug Disposal programs, an ongoing Electronics Collection, a Tire Collection as well as the Hazardous Waste Clean Sweep Program.

**VOLUNTEER CALL**

The Manitowoc County Recycling Center is looking for volunteers to assist with tasks at the Compost Sites and Recycling Depot. This is a great way to learn more about recycling and composting in your community! All volunteers will be trained by the site manager. If you are interested in helping with recycling and composting efforts in our community this is a great and flexible opportunity. **Volunteers  
Needed**

- All volunteers must fill out the Manitowoc County Volunteer Application and meet with the Operations Manager.
- All volunteers will receive initial training and checkups from the site Operations Manager.
- Volunteer tasks include:
  - Control litter by routinely monitoring the sites and picking up... help keep our compost and environment clean
  - Notify the main office of any illegal dumping.
  - Greet and direct customers at the Recycling Depot, Basswood Compost Site, or Woodland Compost Site.
  - Help answer customer questions.
  - Inspect incoming loads and provide friendly feedback.
  - Record temperatures in compost piles.
  - Tasks can be modified to the comfort level of each volunteer.
- Volunteers earn freebies or discounts for various products and services at our facility as they log hours. Discounts include compost products and electronics recycling services.
  - For every 10-15hrs of service, volunteers may receive a voucher for a yard of wood mulch, screened compost, disposal of a small tv, or items of similar value.
- The Recycling Center will provide a reflective safety vest, trash grabber, a container/bag, and any informational handouts that may be needed.
- Dress for the weather! Work is primarily outdoors.
- Bring your favorite gloves and footwear appropriate for dust or mud.
- Work when you want and for how long you want.
- Volunteer hours can be used to fill service requirements for school or court if needed.

RECYCLING DEPOT

The Manitowoc Recycling Center maintains a residential drop off area at the Recycling Center Main Office located at 3000 Basswood Road. It is open Monday-Friday from 7am to 4pm, and Saturday from 8am to noon. This site is intended for use by all county residents. There is no trash or garbage drop off at this location. Contact a local hauler or the Ridgeview Landfill for disposal of trash. Different municipal drop off sites may be more accessible to you depending on the city, township or village you are from.

General Drop Site Guidelines

- Place your recyclables in the bunker or receptacle labeled for that material.
- Remove any plastic bags or strings and take them home with you to place in your trash.
- Do not place nonacceptable items in the bunkers or receptacles.
- Do not place materials outside receptacles on the ground.
- Large loads of cardboard, paper or plastic can be placed on appropriate pile on the tipping floor.
- Use caution driving through the drop site and on the tipping floor.
- Due to Covid-19, please practice social distancing and other precautions at the recycling depot.



The recycling and compost areas are monitored for illegal dumping, littering, and other issues. Please follow all posted guidelines.

**Paper**  
Includes newspapers, junk mail, magazines, computer paper, books with metal or plastic binding removed etc.. Paper should be clean and dry. No paper contaminated with food or oil. No paper coated with foil, plastic or heavy glue. No plastic/foil wrapping paper.



**Plastic**  
Check for a neck. **We only accept #1 and #2 bottles and jars.** Remove the caps, rinse and flatten. No tub shaped containers or bottles that contained oil or pesticide (even if rinsed). No plastic wraps, films, bags, trays, pails, packaging peanuts, Styrofoam, or any other non bottle shaped item. Please do not tie milk jugs together or tie in plastic bags.



**Glass Bottles**  
Any color glass bottle or jar can be recycled. Put into designated bunker. Remove lids or caps and rinse. No window glass, mirrors, light bulbs, clay, ceramics, drinking glasses or ovenware.



**Cartons**  
Cartons include shelf stable and refrigerated containers for wine, milk, juice, cream, soy milk, soup, and egg substitutes. Drop off cartons with the plastic bottles. They should be emptied and flattened.



**Cardboard**  
Should be clean and flattened. No soiled cardboard or cardboard coated with wax, tin, or plastic.



**Cans**  
Tin, steel, and aluminum cans. Coated cans, foil, and pie tins are ok. Empty and rinse out food residue.

SCRAP METAL DUMPSTER

The Recycling Depot now has a scrap metal dumpster available for your convenience. It is for clean scrap metal only, including steel, iron, copper, sheet/cast aluminum, tin, and mixed metals. Please remove excessive non-metal components.

- NO propane (or other) tanks
- NO electronics or appliances
- NO batteries or lamps
- NO garbage, plastic, wood, or rubber
- NO chemicals, gas, oil, or other hazardous wastes.
