#### To the Citizens and County Board of Manitowoc County,

Thank you for taking the time to read the 2022 Manitowoc County Sheriff's Office Annual Report.

I want to start by thanking the County Board of Supervisors and County Executive Bob Ziegelbauer for supporting a wage adjustment for our correctional staff for 2023. Staffing our jail in 2022 was a struggle, and we recognized that a change was needed to recruit and retain staff in our correctional facility.



This past year also brought great opportunities to the Sheriff's Office. I strongly support increasing and enhancing our partnerships with Federal, State, and local governments. Our office was presented with an opportunity to help support the Aging and Disability Resource Center (ADRC) with the "meals on wheels" program. Our jail kitchen supported this vital program to help provide high-quality meals to those in need in Manitowoc County. This endeavor resulted in over 31,000 meals coming from our kitchen. We look to continue supporting this effort into the future.

We have increased our technological capabilities this past year as well. In July, we started our new Drone Team. Currently, we have 12 trained pilots with five drones supporting our public safety mission. In the short existence of this program, our office has assisted in over 30 events in the community, including but not limited to, missing children, fire scenes, motor vehicle accidents, crime scenes, and suspects at large. This valuable piece of technology has been a great addition to the service we provide to our citizens and our fellow local first responders.

We look to you for your continued support as we progress our office into the future for the greater good of the people of Manitowoc County.

### **Operations – Patrol Unit**

The Manitowoc County Sheriff's Office Patrol Unit is responsible for enforcing and upholding both State and local laws, responding to calls for service, citizen assists, initial criminal investigation, accident investigation, security checks and community engagement events.

The Patrol Unit is comprised of the following;

- \* 3 Lead Shift Lieutenants
- \* 6 Lieutenants
- \* 25 Patrol Deputies
- \* 2 K9 Deputies (Leon and Rocky)

The patrol unit currently works three eight-hour shifts. Each shift is supervised by a Lead Lieutenant and two additional Lieutenants who report to the Lead. The entire unit is included under the Operations Division which is led by Major Jason Orth.



Manitowoc County has a total area of 1,494 square miles of which 589 square miles is land. The Sheriff's Office has primary jurisdiction for all of the unincorporated towns, six of the villages, and all inland lakes within Manitowoc County including Lake Michigan and its shoreline. Deputies are the initial response to most incidents within Manitowoc County which can be anywhere from citizen assist requests to major emergency situations. Besides their normal responsibilities, many deputies assist with agency training and are a part of the Sheriff's Office specialty teams.





# **Operations – Investigation Unit**

The Investigative Unit falls underneath the Operations Division which is overseen by the Major of Operations. The investigative unit is comprised of both the Detective and Metro Drug units. Within 2022 the Detective unit was able to add an additional detective and a Criminal Support Specialist (CSS) to assist with the caseload and evidence management. The Detective unit is comprised of a Lieutenant of Detectives who oversees five detectives and the civilian CSS. The members within this unit are all cross trained investigators who specialize in certain areas of expertise.

During 2022, the most investigated cases were as follows:

# **Operations – Drug Task Force Unit**

The Multi-Jurisdictional Drug Task Force (DTF), is comprised of the Manitowoc County Sheriff's Office (lead agency) and both the Manitowoc Police Department and Two Rivers Police Department. Full-time personnel assist with the DTF which has been in place since the early 1980's. Many new challenges involving health and safety drug threats were encountered in 2022 along with significant Methamphetamine and Fentanyl drug seizures.

The City of Manitowoc continues to be the jurisdiction where the majority of the DTF investigations take place. While the prescription medication caseload has decreased, DTF investigations have been directed toward Methamphetamine and Fentanyl distribution.

In 2022, the DTF conducted fourteen drug-related search warrants. They initiated approximately 137 drug-related cases with 52% of the cases involving Methamphetamine. *Fentanyl related cases continue to increase and pose the most significant health and safety threat to the community.* 


The investigators conducted numerous drug related presentations that provided current drug trends and information sharing allowing the community to remain vigilant.

The DTF has two Federal Task Force officers that are partially funded. **Drug Enforcement Administration and U.S. Marshal Service** resources were utilized on numerous cases. These additional resources provide the DTF with the ability to enhance investigations and the ability to refer large-scale drug distribution cases to the U.S. Attorney's Office for prosecution. This cooperative relationship has been vital to numerous local investigations.

The DTF will continue its efforts directed toward the most significant drug threat in the community and assist local, regional, state and federal law enforcement agencies with information and intelligence gathering.

### **K9 Unit**

The Manitowoc County Sheriff's Office currently has two K-9 teams, which are K-9 Leon with his handler Deputy Chris Hemauer and K-9 Rocky with his handler Deputy Jon Schwede. Both of our K-9 teams are dual purpose with patrol and narcotic capabilities.

Some of the patrol capabilities consist of tracking, building searches, area searches, and crowd control. Some of the narcotic capabilities consist of sniffs on





vehicles, postal packages and assisting school personnel with locker searches. Our K-9 teams are also very involved in our community with demonstrations and public engagements.

Our K-9 teams train a minimum of 16 hours per month to keep their skills refined as well as attend annual certification trainings.

The Manitowoc County Reserve Deputy Program is currently comprised of retired and current law enforcement officers as well as those individuals right out of college looking for future full-time employment as a law enforcement professional. Our reserve deputies provide assistance with a multitude of different functions and responsibilities for the Sheriff's Office which include:

- Role players for training scenarios



During 2022 the reserve deputies combined to work 4,830 hours and 16 non-county events where they are contracted by a business or organization for security.

The Manitowoc County Sheriff's Office is grateful for these individuals and the important role they play in the day to day operations and success of the agency.

### **Snowmobile and Boat Patrol**

The Manitowoc County Sheriff's Office Boat and Snowmobile units are utilized for monitoring the trails, rivers and waterways within Manitowoc County to provide education and to uphold the State recreational laws within Wisconsin. These programs are often funded anywhere between 60 to 80% annually through the Department of Natural Resources (DNR).

The Sheriff's Office snowmobile and boat units are comprise of both full-time and reserve deputies that perform the enforcement of the State of Wisconsin's recreation laws that apply within Manitowoc County.



#### Snowmobile Patrol

Manitowoc County currently has over 248 miles of snowmobile trails that are divided into six sections. Unfortunately, due to the lack of snow accumulation the snowmobile trails did not open in 2022.

#### **Boat Patrol**

The boat patrol unit provides education and enforcement to those utilizing the waterways within Manitowoc County. These include the rivers, inland lakes as well as Lake Michigan. During 2022, the Manitowoc Sheriff's Office Boat Unit worked 288 hours. During this timeframe the following types of enforcement were complete:



- **★** Written Warnings 42
- **★** DNR Citations 29

The primary focus of both recreational patrol units is to provide education to those utilizing the Manitowoc County waterways and trails, to ensure an enjoyable experience for all, and provide enforcement to help keep everyone safe while in a boat or on a snowmobile

# Specialty Teams – SWAT /CNT TEAM

#### **SWAT Team**

The multi-jurisdictional SWAT team includes members from the Manitowoc County Sheriff's Office (lead), Manitowoc Police Department, Two Rivers Police Department, and Two Rivers Fire Department. This team is a designated unit of law enforcement officers and tactical emergency medical support (TEMS) that is specifically trained and equipped to work as a coordinated team to resolve critical incidents.



This includes, but is not limited to, hostage taking, barricaded suspects, snipers, terrorist acts and other high-risk incidents. As a matter of office policy, such a unit may also be used to serve high-risk warrants, both search and arrest, where public and officer safety issues warrant the use of such a unit.

During 2022, the SWAT team cooperated in extensive training to help prepare the team for actual call-out requests. The SWAT team was requested on nine separate instances during 2022 for situations involving search warrants, armed subjects and barricaded subjects.

#### **Crisis Negotiators Team (CNT)**

The CNT is a joint agency county-wide team comprised of seven negotiators from the Manitowoc County Sheriff's Office, Manitowoc Police Department, Two Rivers Police Department and Mishicot Police Department.

Each team member is responsible for completing the basic negotiator training as well as bi-monthly team training. During the monthly training the team reviews past callouts, reviewing their equipment and procedures, and work through team scenarios.

In 2022 the CNT was activated on three call-outs.

# Specialty Teams – *Dive & Recovery Team*

The Dive Team performs search and recovery operations in Lake Michigan, small lakes and other bodies of water within Manitowoc County. The team consists of nine members, four of which are recent additions to the team in 2022. The nine members include eight from the Sheriff's Office and one from the Manitowoc Police Department, allowing for a joint operation.

During 2022 the team trained monthly from May through October along with one ice dive in the winter. Training, teamwork, experience and knowledge of the equipment are important aspects that make this team successful. The team was also able to purchase a side scan sonar for the Sheriff's Office boat and two full face dive masks with communications.

The team was utilized on two separate call-outs to assist the Manitowoc Police Department in the recovery of two deceased individuals as well as a vehicle. The recoveries were successful allowing closure for the families.

Annually the team completes training to maintain certification in ice dive, deep dive, night dive, and search and recovery training on in-land lakes, ponds and Lake Michigan.



# Specialty Teams – Drone Team

In July of 2022, the Manitowoc County Sheriff's Office created an Unmanned Aerial System team. The purpose of the Drone Unit is search and rescue, crash reconstruction, fugitive apprehension, assisting local Fire Departments/EMS, and Manitowoc County building inspections. Twelve members have completed and passed the testing in accordance with the FAA Part 107 guidelines.

Within its first six months the team received 32 on-duty pilot calls to assist deputies and other law enforcement agencies. The drone was used to photograph crash scenes, search for individuals both lost and wanted, provide a security survey of an event site, provide lighting for a high risk traffic stop, searched lakes for potential victims, checked a fire scene for hot spots and photographed scene, gathered video evidence, and was utilized with an interpreter over the loudspeaker to give instructions to an armed suspect.

Initial training for the team included a 40 hour video to prepare for the Federal Aviation Administration Part 107 Test to become FAA UAS certified pilots. Pilots then participated in an additional 8 hours of training to familiarize them with the drone and basic flight maneuvers. Advanced training covering high altitude flight, payload delivery, visual observer flight, and night search tactics with thermal imaging was also completed.




# Specialty Teams – Honor Guard

The Manitowoc County Sheriff's Office Honor Guard was formed by six agency members in 2012. Since then the team has continued to progress not only with their knowledge and experience, but also with the uniform that was hand selected by all original team members. Currently the Honor Guard Team consists of seven members which include four patrol deputies, one detective, one jail sergeant and one patrol lieutenant.

In 2022, the Honor Guard Team responded to a total of eight team call-outs, seven of them being partial team call-outs and one being a full team call-out. The team trained for a total of 10 hours, primarily prior to each event that they participated in.

### **New Positions Added in 2022**

In 2022 the Manitowoc County Sheriff's Office added three new positions to our team which included a civilian Criminal Support Specialist, a Detective and a Professional Standards Lieutenant.

#### **Criminal Support Specialist**

The Criminal Support Specialist works as an evidence room manager and a certified evidence technician. The CSS's duties include the daily intake of evidence, sending items to the WI State Crime Lab, handling the intake and release of firearms as it relates to surrenders and property returns. The CSS is also trained and certified to assist Law Enforcement on scene and Search Warrants to maintain the chain of custody of the evidence. Over the last year, the evidence room went through a complete remodel to aid in the efficiency and organization of the evidence room.

#### **Professional Standards Lieutenant**

The Professional Standards Unit consists of a lieutenant who oversees the training and development of employees at the Sheriff's Office. Lieutenant Sean Littlefield was selected to fill this spot from his prior position of lead 3<sup>rd</sup> shift lieutenant. The Professional Standards Unit falls underneath the supervision of the Major of Support. Responsibilities of this position include:

- ★ Hiring process
- ★ In-house training coordinator
- Oversight of the field training programs
- **★** Social media/events coordinator

- \* Public information officer
- Internal affairs
- \* Reserve deputy program
- ★ Wellness Team
- \* Training equipment inventory

#### **Detective**

The primary purpose of this position is to investigate white collar crimes (fraud/theft); however, can also be utilized as a general purpose detective, assisting with any overflow of case work. The addition to the Detective Unit has benefited the agency through workload distribution, schedule and training flexibility, the opportunity for further specialized training to occur within the Sheriff's Office, and to assist the Metro Drug Unit.

# **Training Unit**

The addition of the Professional Standards Lieutenant position has opened up the doors to establish a training program that is more encompassing, allowing for team members the ability to gain their 24 hours of annual certification training through our agency, attending our training courses, with our trainers.

In 2022, the Sheriff's Office trainers put on the following in-service training sessions for its members:

- ★ WI State Annual Pistol Qualification (2 hrs)
- ★ In-service #1 Firearms / Rifle qualification / Tactical shield familiarization (8hrs)
- ★ In-service #2 Firearms / Pepperball certification (8 hrs)
- **★** EVOC Emergency vehicle operations course (4 hrs)
- ★ CPR/ Blood borne Pathogens / Narcan (4 hrs)
- **★** WI State Pistol and Rifle Qualifications / Low Light Shooting (2 hrs)

Not only have we provided our team members with in-house training but continue to looks for ways to enhance our training program by sending individuals to outside specialty trainings. This allows for growth, expertise and knowledge which can be brought back to the rest of the agency.

We look at ways to advance our knowledge and experience through training that encompasses scenarios with the goal of being prepared for real life situations.
