A motion was made by Gerroll, seconded by Brey to defer making a recommendation and move the question of project financing to the Finance Committee of the County Board. Discussion. Motion carried 10-2 with Supervisors Martell, Gerroll, Brey, Hansen, Sitkiewitz, Behnke, Baumann, Klein, Judge Dewane, and citizen member Delsman voting Aye, and Supervisor Naidl and Phipps voting Nay.
