**Questions to consider:**

- Scheduling- are they available for the days and times requested? How soon for services to start?
- What is their cancellation policy? What if the worker is not available?
- What type of services are you looking for and does the agency provide the services you need (i.e. bathing, dressing, medication reminders, housekeeping)? Can services include certain activities or hobbies?
- How are staff trained to provide these services? What experience, qualifications, licensing or certifications does the agency have?
- What is the cost per hour? Is there additional travel costs?
- Does the agency have a minimum or maximum length of time per visit or week?
- Is there a fee for an assessment or a “startup” fee?
- What is the agency’s policy surrounding filing a complaint or grievance? What is their policies surrounding protecting your loved one from any neglect, abuse, or misappropriation? Who supervises the quality of care being provided?
- Does the agency have anyone willing to give a reference or have references available to review?
- Is there a written care plan?
- What payment options are available?
