### **Home Health Agencies**

Home health agencies (HHAs) provide skilled health and social services in the home. Skilled services are provided by or under the supervision of a licensed professional. Services may include skilled therapies, wound care, pain management, chronic disease management, post-operative care, medical social services, and more. It may include home health aides to provide assistance with personal cares. Licensing and regulation is through the Wisconsin Department of Health Services (DHS), Division of Quality Assurance (DQA). Home health care is coordinated through your physician or discharge planner. Medicare, Medicaid, and most insurance plans typically cover home health care if it is determined medically necessary, contains a physician's order, and meets homebound criteria. Call your provider directly for more information.
