## JUNIOR FAIR SWINE

1. Entry Day – **Tuesday, August 20**, between **10am-11:30am** with unloading of animals only on the **Southside of the Lesters Building**. Must be penned by 11:45am.
2. Judging Day – **Wednesday, August 21**, starting at **8am**, in the Multi-Purpose Building.
3. Release Day – Swine to be released on **Sunday, August 25**, market swine will be released at 4:30pm with the contract hauler only. All others will be released at 5:30pm along with decoration and pen breakdown.
4. **ALL JUNIOR SWINE EXHIBITORS ARE REQUIRED TO ATTEND AN EXHIBITOR MEETING ON TUESDAY, AUGUST 20, IMMEDIATELY FOLLOWING ENTRY TIME OR BY 11:45AM IN THE LESTERS BLDG. RULES AND EXPECTATIONS WILL BE REVIEWED, DISCUSSED AND STRICTLY ENFORCED THEREAFTER.**
5. **All exhibitors in this department must call the Superintendent by no later than August 1 with the number of animals they will be bringing. If exhibitor is over/under of the called in amount by more than one (1) animal, there will be a penalty of not exhibiting at the next County Fair.**
6. Pens will be assigned by the Junior Fair Swine Superintendent. All exhibitors must show with the youth organization whose leader approved the entry.
7. Each exhibitor must care for and feed the animal or make arrangements to have the animal fed or cared for and cleaned. **All animals must be kept clean, fed, watered and in place until checkout time on Sunday. An inspection will be done daily after 8am by the Superintendent. If an animal is determined to be neglected in any way by the Superintendent and/or Expo board member, the Exhibitor will be notified. Failure to keep pen clean and animal fed could result in forfeiture of premiums and possibly excluded from participation the following fair year.**
8. No changes will be allowed after registration forms are submitted.
9. **An exhibitor can weigh-in and exhibit up to two (2) market hogs. Must be in separate lot numbers in Class A – Market Swine.**
10. After final weigh-in, swine will be divided by Lot Number and Weight for Class A – Market Swine. This will be determined by the superintendent.
11. Champions and reserve champions will be chosen by the judge.
12. Champion Ribbons and/or trophies will not be awarded unless there is competition.
13. **HEALTH REGULATIONS:** See WI County, District, & State Fairs **2024** Animal Health Rules and Regulations located on the website. Any required health certificates/copies must remain in the Expo office during the fair.
14. Exhibitors must show their own animals. The same animal must be used in all heats and finals. If assistance is needed, it will be provided by the ring help.
15. **JUNIOR FAIR EXHIBITORS MUST WEAR THEIR EXHIBITOR NUMBERED HAT/HARNESS WHILE SHOWING. FAILURE TO WEAR THE EXHIBITOR NUMBER WILL RESULT IN PREMIUM MONEY FORFEITURE!**

2. **Purebred entries must be accompanied with the appropriate paperwork indicating the purebred and must be 75% purebred status with papers.**

## HERDSMANSHIP

Herdsmanship awards will be made in two (2) groups divided according to the number of animals exhibited.

### HERDSMANSHIP SCORE CARD

Animal & Living Space	40 points
Exhibitors	15 points
Club Sign, Decorations & Cards	15 points
Aisles	20 points
Storage & Feed	<u>10 points</u>
Total	100 points

1. All clubs are automatically entered.
2. Clubs cannot use decorations wider than 11-12 inch boards that are furnished.
3. Consideration will be given to maturity of animals in the exhibit. Awards and ribbons will be presented on Sunday, **August 25 at 4:30pm.**
