An adult family home (AFH) is a place where 1 to 4 adults (not related to the operator) reside and receive care, treatment, or services that are above the level of room and board. This may also include up to 7 hours per week of nursing care per resident. AFHs that are 3-bed and 4-bed are licensed and regulated by the Wisconsin Department of Health Services (DHS), Division of Quality Assurance (DQA).
