How do I schedule my ride?

To make your reservation, call the One-Stop-Shop Monday-Friday, 8:00am-4:00pm, at (920)686-6977. All trip reservations must be made 2-3 business days in advance. Same day service is not provided. Reservations are accepted, and encouraged, up to 14 days in advance. Our staff will assist you with specifics of pick-up and return times, and door-to-door service, when you call to set up your reservation.

Cancellations

In the event of a cancellation, we request that you contact the One-Stop-Shop ASAP at (920)686-6977. Please try to give at least two hours notice to all cancellations.

Who can use the Rural Transportation Program?

- Manitowoc County residents age 60+, or Manitowoc County residents age 18+ with a disability
 - o must have no access to/ability to use other transportation

Where can I take the van?

- Anywhere in Manitowoc County
- Medical appointments, shopping, social outings, etc.

What information do I need when scheduling my ride?

- Date and time of appointment
- If a return trip will be needed

What should I bring?

• During your initial reservation, our staff will explain the policies and procedures to ride in the van.

What if I need help?

- Door-to-door assistance is available to all passengers.
- All vans are equipped with a pull-out ramp to accommodate and secure individuals using a walker or wheelchair.
- Seat belts are required for all passengers

How much will my trip cost?

• Round trip fare is \$12 for a single rider.
