A community-based residential facility (CBRF) is a type of assisted living facility in which five or more unrelated adults live together in a community setting. Services include room and board, supervision and support services, and can include up to three hours of nursing care per week. A CBRF may offer respite care services. Licensing and regulation is through the WI Department of Health Services (DHS), Division of Quality Assurance (DQA).
