Each staff member and volunteer who has access to students at the camp must have a background check run every 2 years by the district.</p> <p>CORRECTIVE ACTION(S): Provide background checks every 2 years for returning camp staff and any additional individuals who reside on the camp's premises. Correct By: 01-Jan-2025</p> <p>CODE CITATION: ATCP 78.26 (1) (d) Background Check Frequency. All existing camp staff prior to extending employment shall have a background check performed at least every 2 years. This requirement also applies to any additional individuals who reside on the camp's premises with access to campers. P</p>


