The Social Security Administration (SSA) may appoint a representative payee to beneficiaries who are incapable of managing or directing the management of their Social Security or Supplemental Security Income (SSI). Representative payees can be family, friends, or payees through a qualified organization appointed by SSA. Qualified organizational payees may collect a monthly fee from a beneficiary’s monthly payment, determined by Social Security, for providing payee services.
