## **Vouchers**

Vouchers are not limited to units located in subsidized housing projects. Vouchers may be accepted by private landlords who have agreed to rent under the program, which may include your current residence if it meets the qualifications.

In Kewaunee County, Integrated Community Solutions (ICS) administers the voucher program for the Wisconsin Housing and Economic Development Authority (WHEDA). Applicants are pulled from the waiting list based on application date and time. Eligibility is based on gross annual income (which may vary by location), number of household members, and criminal background checks.

Residents must ask a landlord **prior** to signing a lease agreement if WHEDA vouchers are accepted.
