Hospice agencies provide care to terminally ill patients. Hospice care can be provided at home or in another setting, such as a nursing home or assisted living facility. Hospice provides physical, emotional, and spiritual care that is tailored to each individual. To qualify for hospice, you must have a life-limiting illness with a life expectancy of six months or less if the disease were to run its normal course. Hospice requires a physician's order.
