Candidates for statewide and judicial offices will file nomination papers and declarations of candidacy with the Wisconsin Elections Commission. Municipal candidates file with their respective municipal clerk. School board candidates file with their respective school district clerk. Sanitary district candidates file with the municipal clerk of the municipality which has the most area located within the sanitary district.

**Primary Election**

If a primary is necessary, the primary will be held on Tuesday, February 18, 2025.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID, you may obtain a free ID for voting from the Division of Motor Vehicles.
