Hospice provides physical, emotional, and spiritual care that is tailored to each individual. Services include, but are not limited to, skilled nursing care, care management, durable medical equipment, medications, home health aides' services, grief support, and more. Services can be provided at home or in another setting, such as a nursing home or hospital. To qualify for hospice, you must have a life-limiting illness with a life expectancy of six months or less if the disease were to run its normal course. Medicare, Medicaid, and most private insurance companies cover hospice services. Contact the provider directly for more information.
