FOR CANDIDATES, the first day to circulate nomination papers is December 1, 2025, and the final day for filing nomination papers is 5:00 p.m. on Tuesday, January 6, 2026. Judicial Officer candidates file with the Wisconsin Election Commission. County candidates and Municipal Judge candidates file with the Manitowoc County Clerk. Municipal candidates file with their respective municipal clerk. School Board candidates file with their respective school district clerk.

If a primary is necessary, the primary will be held on Tuesday, February 17, 2026.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID you may obtain a free ID for voting from the Division of Motor Vehicles.
