

MEETING OF THE COUNTY BOARD OF SUPERVISORS  
MANITOWOC COUNTY, WISCONSIN

Tuesday, May 19th, 2026

6:00 P.M.

Pursuant to Wis. Stats. 59.04, the County Board of Supervisors of Manitowoc County, Wisconsin convened in open session at the Heritage Center, in the City of Manitowoc, being the 19<sup>th</sup> day of May 2026, for the purpose of transacting business as a Board of Supervisors.

Chairman Phipps called the meeting to order at 6:01 p.m.

Supervisor Lillibridge gave the invocation, followed by the Pledge of Allegiance to the Flag by the entire assemblage.
