Questions to consider:

- Are they available for the days and times requested?
- What is their cancellation policy?
- What is the policy if the home care worker is not available?
- What type of services are you looking for and does the agency provide the services you need? Can services include certain activities or hobbies?
- What training does the staff receive to provide these services?
- What experience, qualifications, or certifications does the agency have?
- What is the cost per hour?
- Is there additional travel costs?
- Does the agency have a minimum or maximum length of time per visit or week?
- Is there a fee for an assessment or a “startup” fee?
- What is the agency’s policy surrounding filing a complaint or grievance? What are their policies surrounding protecting your loved one from any neglect, abuse, or misappropriation?
- Who supervises the quality of care provided?
- Does the agency have anyone willing to give a reference or have references available to review?
- Is there a written care plan?
- What payment options are available?
